A TRIBUTE TO MRS. CAROLYN MCHALE

On January 1, 2026 Carolyn McHale departed for Heaven. On the 29th of January a Memorial Service and a Celebration of Life was held at Patriot's Colony to honor Carolyn. She was our Chapter's Award-Winning Communication Committee Chairperson. who volunteered to take on committee responsibilities in 2017 after her husband John joined VIPMOAA as an Associate Member. To say that she was a fantastic addition to our Board of Directors would underestimate the significance of her contribution to VIPMOAA. She was the heart and soul that made our Chapter operate and set a record of MOAA National Awards for our Newsletter and our Website which she raised to an outstanding level. She was the steady hand that guided all of our Chapter's communications with members and with the media. Carolyn enhanced everything she touched and ensured that our Chapter maintained its MOAA "Five Star" ranking.

Carolyn was born in Pittsburgh, Pennsylvania in November of 1942. She graduated from Drexel Institute of Technology in Philadelphia in 1965 with a degree in Biology. For her first eight years, Carolyn worked for the Armed Force Radiobiology Research Institute in Bethesda, Maryland and then moved to the National Institute of Health. Over time, she worked in 5 of the 27 National Institute of Health's Institutes and became Chief of the Science Information and Data Systems at the National Institute of Arthritis and Musculoskeletal and Skin Diseases. In 1996, she was recognized and selected as one of the Top 100 women in computing in the United States by Business Week. VIPMOAA had the wonderful good luck to have her serve as our Communications Committee Chairperson.

Carolyn was so much more than a talented researcher and computer wiz. Yes, Carolyn was really smart! But she was so much more. She was one of the most dedicated, competent, creative, caring, and gracious persons one could ever meet. She cared about people, her country, and her family. She was tireless in making sure everything and anything that she took on as responsibility was completed on time and with precision. She was truly a "Great Woman" who will be sorely missed by so many people. Carolyn McHale "So Long and God Speed".

VIRGINIA'S GOVERNOR:

Virginia's newly installed Governor, Abigail Spanberger, recently ended state cooperation with federal immigration officials (ICE). One of her initial actions was to rescind former Governor Glenn Youngkin's order that deputized the State Police to assist ICE. Her executive action fulfilled a campaign promise to shift away from assisting in immigrant arrests, though local law enforcement remains free to cooperate if they choose. Youngkin had previously issued orders promoting cooperation to remove "dangerous criminal illegal immigrants," while Spanberger's new executive order signals a policy change focusing on immigrant rights and limiting state involvement in federal immigration enforcement.

CONGRESSMAN WITTMAN:

1. Secured \$3,254,400 for Bethel Manor Elementary School. The school has a highly mobile student population that is 97% military-connected, and adding additional classrooms will meet the growing education capacity needs of students from the surrounding military bases.
2. The Tax Cut Law passed last summer incentivizes energy production, reduces costs, provides made-in-America incentives and research and development (R&D) expenses to support energy dominance, and strengthens U.S. energy security by supporting the Strategic Petroleum Reserve, the United States' emergency stockpile of crude oil.
3. Voted in favor of a bill that included the *Department of Defense Appropriations Act*, which among other things increases funding by \$41 million for Project Pele, which supports advancements in nuclear power development. Strengthens domestic supply chains by providing a \$20 million increase for TRISO fuel.
 - Includes an additional \$30 million for the Defense Community Infrastructure Program.
 - Advances drone defense capabilities by allocating \$5 million for the Counter-UAS Testing and Research Center at Virginia Tech.
 - Increases funding by \$45 million for State Space Launch Ranges Services and Capabilities to support operations at the Virginia Spaceport Authority

SENATOR KAINE:

1. The annual defense bill, which includes a pay raise for servicemembers, funding for military construction in Virginia, and investments in our shipbuilding programs, was signed into law. It also included my bipartisan legislation to repeal the 1991 and 2002 Authorizations for Use of Military Force, formally ending the Iraq Wars. After many years, the passage of this legislation means we can formally close this painful chapter in our nation's history.

2026 COST-OF-LIVING ADJUSTMENTS

ANNOUNCED BY OFFICE OF THE ASSISTANT SECRETARY OF WAR

The Cost-of-Living (COLA) information listed below is a partial extract distributed by the Office of the Assistant Secretary of War. COLAs are effective Dec. 1, 2025. COLAs for retired pay:

1. The retired pay COLA for those who first became members of a Uniformed Service before Sept. 8, 1980, is specified according to the effective date of their retirement, as follows:

Retired pay based on rates of pay effective	Percent increase	10 U.S.C. authority
Before Jan. 1, 2025	2.8 percent	1401a(b)(2)
Jan. 1 - Dec. 31, 2025	2.6 percent	1401a(c)

2. The retired pay COLA for those who first became members of a Uniformed Service on or after Sept. 8, 1980, including those members covered by the High-3 or Blended Retirement System (BRS), is specified according to the effective date of their retirement, as follows:

Retirement Effective	Percent increase	10 U.S.C. authority
Before Jan. 1, 2025	2.8 percent	1401a(b)(2)
Jan. 1 - March 31, 2025	2.6 percent	1401a(c)
April 1 - June 30, 2025	1.6 percent	1401a(d)
July 1 - Sept. 30, 2025	0.7 percent	1401a(d)
Oct. 1 - Dec. 31, 2025	0.0 percent	1401a(d)

3. The retired pay COLA for those who first became members of a Uniformed Service on or after Aug. 1, 1986, and also elected to receive a career status bonus under the provisions of sections 322 (as in effect before Jan. 28, 2008) or 354 of Title 37 U.S.C. as specified according to the date of their retirement, as follows:

SURVIVING SPOUSE LIAISON – COL (Ret.) Suzanne Evans. This is a note to introduce myself and to let our members know, especially our Surviving Spouses, that I have volunteered to be the newest member of our Board of Directors, as the Surviving Spouse Liaison. I am very proud to be an Army Nurse retired with 30 years' experience. I grew up as an Air Force brat living in over fourteen locations ending up in Boise, Idaho. I served as an Army reservist from 1976-1977 and then on active duty until 2016. While I mainly served in Army Medical Centers on the western part of the United States beginning in Fort Ord, California, then Madigan Army Medical Center (AMC), I also served a tour at Frankfort AMC in Germany and my final tour was at Tripler AMC, Hawaii. I gave up my nursing license two years ago. For 12 years, I enjoyed being a Red Cross volunteer at Tripler AMC. Two years ago, I moved from Hawaii to Williamsburg to be close to my granddaughters.

I have some knowledge of the grieving process and the tools to assist survivors. As the Chapter Liaison I am here to help and educate when needed. It is my hope that my nursing experience and my empathy for those who have lost a loved one will aid me in being proactive in support of surviving spouses and our Chapter.

As an initial input to our members, I want to highlight the MOAA web site and the resources in the “Surviving Spouses Corner”. CHANGES BEING DEVELOPED TO IMPROVE THE JROTC SCHOLARSHIP PROGRAM

As Tom Swanson our ROTC Committee Chairman related in his article in the January Newsletter, the Board of Directors is developing a plan that will improve the JROTC scholarships that the Chapter offers to cadets. Currently, the senior instructor at each of the eleven high schools on the peninsula that our Chapter supports submits a name of one cadet in his school that is then offered a scholarship award of \$500. Over the past few years only 7 to 8 cadets each year have matriculated to a college and received the award. The Board proposes to make the scholarship award larger (\$1,000) and competitive within and between the JROTC Programs. The changes would allow more than one JROTC cadet from a school to apply and the Chapter would make the final the final selection of the most qualified candidates. Details of the planned changes and the criteria for selecting the cadets are being developed.

IMPORTANT DATES IN MILITARY HISTORY FOR February

6 February 1778 – Treaty of Alliance signed between France and the Second Continental Congress brings France into the American Revolutionary War.

8 February 1861 – The Confederate States of America (CSA) was formed by South Carolina, Mississippi, Florida, Alabama, Georgia, Louisiana, and Texas.

25 February 1945 – US Marines Hoist the American Flag on Mount Suribachi, Iwo Jima.

1 February 1968 – TET 1968 – Vietnam War.



FEBRUARY IS BLACK HISTORY MONTH

A Black Navy Hero of WWII - Dorie Miller (1919-1943)

Dorie Miller served in a noncombat role in the Navy on the battleship West Virginia when it was attacked at Pearl harbor. Since the Navy was segregated, African Americans were not given combat roles or weaponry training, so Miller's ability to shoot down enemy planes was remarkable. He was the First African American awarded the U.S. Navy Cross!



Dorie graduated from high school in Waco, Texas and enlisted in the Navy as a kitchen worker. On December 7th, Dorie was up at 6 a.m. to begin work. The Japanese attack began and he reported to his assigned battle station. Miller was a football player and a Navy boxing champ and his job was to carry the injured to safer quarters. When Dorie returned from carrying the mortally wounded ship's captain, he saw the planes were still dive-bombing the naval fleet. He picked up a 50-caliber Browning antiaircraft machine gun and managed to shoot down 3 to 4 enemy aircraft. He fired until he ran out of ammunition.

The editor of the Pittsburgh Courier, one of the country's most widely circulated black newspaper, sent a reporter out to identify this "Heroic Negro Messman". On May 27, 1942 Miller received the Navy Cross for his extraordinary courage in battle. His rank was raised to Mess Attendant First Class. After a bond fund raising tour in the US, Miller was sent back to serve on a new escort carrier, USS Liscome Bay. The ship was in the Pacific near the Gilbert Islands and on November 24 1943, the ship was hit by a single torpedo fired from a Japanese submarine. Miller went down with the ship. There is a Dorie Miller park in Hawaii and a number of schools and buildings in the U.S. named in his honor. He was one of four Naval heroes featured on the U.S. postal stamps in 2010.

THE BOARD OF DIRECTORS MAKES CHANGES TO VIPMOAA MEMBERSHIP

The VIPMOAA Board of Directors voted in its January meeting to change the existing policy for members joining the Chapter who are 85 or older. The existing policy that had been in effect for the past two years was that any member who reached the age of 85 no longer would pay annual dues, but that any member or new member 85 or older had to be a Chapter member for 5 years before they would qualify for not paying dues. The changed policy eliminates the 5-year Chapter requirement. effective with the Board's vote any new or existing member who has reached the age of 85 will not be charged annual dues.
